Minutes

July 11,2022 Meeting

Mayor Steve Cox called the meeting to order at 6:00 pm followed by the pledge of allegiance.

Council members present were Rob McCann, Tim Harvey, Georgie Eggleston, Terry Tyler, and Jeff Brite.

McCann moved to amend the mayor's proposed agenda by moving the public comments to occur earlier in the meeting after the approval of the warrants/bills and to approve the agenda as amended. Tyler seconded. Motion passed 5/0.

Tyler moved to amend the proposed June 6 meeting minutes to reflect that the City gave Sara Stewart a "donation" and not a "grant" and to approve the proposed minutes as amended with that edit. McCann seconded. Motion passed 5/0.

Brite moved to approve paying warrants/bills. Harvey seconded. Motion passed 5/0.

Tyler read a letter from the Town Homecoming Committee.

Tyler moved to grant permission to the LeRoy Town homecoming committee to upgrade the City's horseshoe pit and repair the City's dance floor/tennis courts at the committee's expense. Tim Harvey seconded. Motion passed 4/0; McCann abstained.

Tyler moved to demolish the current bandstand at the City's expense. Harvey seconded. Motion passed 4/0. McCann abstained.

Tyler moved to donate \$1500.00 to the Homecoming committee, Harvey seconded. Motion passed 4/0. McCann abstained.

The mayor asked McCann, in McCann's capacity as a homecoming committee member, to obtain bids for electrical work the Homecoming Committee would like completed in homecoming park for the council's consideration.

Tyler moved that the City pay for 3 porta potties rentals, with one being handicapped accessible, for the next town homecoming celebration. Brite seconded. Motion passed 4/0. McCann abstained.

Crystal Decker, TrustPoint Insurance, presented a \$6282.12 dividend check to the city.

Phil Jarred, Jarred, Gilmore, Phillips Accounting, presented a 2023 proposed city budget to the council.

McCann moved to schedule the city's budget hearing for August 1, 2022, to coincide with at the next city council meeting. Tyler seconded. Motion passed 5/0.

McCann moved to adopt Resolution 2022-4 finding nuisance associated with livestock kept near the intersection of A Street and Fourth Street and directing the city clerk to serve Aaron Cookus and Amanda Cookus, with an order to abate the livestock nuisance. Brite seconded. Motion passed 4/1; Tyler abstained.

McCann asked the mayor to investigate options for selling city property at 637 Nebraska street.

Tyler asked the mayor to send a letter to the owners of the "old antique store" 309 6th Street and attempt to resolve complaints regarding the building's upkeep before the City determines if the building is a nuisance.

McCann moved to seek bids for moving the city cemetery in 2023. Tyler seconded. Motion passed 5/0.

McCann moved to adjourn. Brite seconded. Motion passed 5/0.
