
WHEREAS, the governing body has the power to cause the repair or removal of any structure located within the city which has become unsafe or dangerous. K.S.A. § 12-1751.

WHEREAS, The enforcing officer, has filed with the governing body a statement in writing that certain structure located at 726 ELEVENTH ST, LEROY, KS 66857 is dangerous, unsafe, or unfit for human habitation. City Code § 4-604.

BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF LEROY, KANSAS:

A hearing is hereby established for D.C. <, 2022, at \$\lambda\$ LeRoy City Hall, 713 Main St., LeRoy, KS 66857. At such hearing, the owners, the owners' agents, any lienholders of record, and any occupant of the structure located at 726 ELEVENTH ST, LEROY, KS 66857 may appear and show cause why such structure(s) should not be condemned and ordered repaired or demolished.

RESOLUTION NO. 2022-10

A RESOLUTION DIRECTING AN ORDER OF VIOLATION BE ISSUED FOR FAILURE TO COMPLY WITH THE CITY'S MOBILE HOME ORDINANCES.

WHEREAS, No more than one mobile home may be located upon any one platted city lot. City Code § 16-403(i).

WHEREAS, No more than one mobile home may be placed on any land contiguously owned by the same person unless such land is permitted mobile home park. City Code § 16-403(k).

WHEREAS. Any willful failure to comply with any provision of City Code § 16-401 et. seq. shall be deemed a misdemeanor punishable by a fine of not less than \$100 per violation and no more than \$500 per violation.

WHEREAS. Each day a person fails to comply with the provisions of City Code § 16-401 et. seq. shall be considered a separate offense.

WHEREAS, the Mayor has reported to the governing body that more than one mobile home is placed on land within the City of Leroy at the address commonly referred to as 629 Third Street LeRoy Kansas.

WHEREAS, the Property is not permitted as a mobile home park.

WHEREAS, the Property is one platted city lot.

BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF LEROY, KANSAS:

- 1. The WHEREAS clauses above are incorporated into this resolution by reference.
- 2. Upon information and belief, the Property is owned by Lonnie and Gladys Yeager.
- 3. The governing body directs the city clerk to serve an order of violation upon Lonnie and Gladys Yeager and any other owner of the Property, and any agent of the owner of the property.
- 4. The order of violation served shall materially conform with the attached order which is incorporated into this resolution by reference.
